

# 令和6年度前期授業料納入方法について

## Announcement concerning Tuition fee payment method

[3分の2額免除]・[半額免除]・[3分の1額免除]・[4分の1額免除]・[一部免除]・[不許可]と決定された学生は、下記の支払額を納入してください。授業料の納入は口座引き落としとなります。令和6年8月26日(月)に引き落としを行いますので、前日までに預金口座の残高として授業料納入金額相当分を確保しておいてください。

半額免除 + 一部免除の学生	→	支払額: 73,950 円
3分の2額免除の学生	→	支払額: 89,300 円
半額免除の学生	→	支払額: 133,950 円
3分の1額免除の学生	→	支払額: 178,600 円
4分の1額免除の学生	→	支払額: 200,900 円
一部免除の学生	→	支払額: 207,900 円
不許可の学生	→	支払額: 267,900 円

最近渡日した等で口座がない場合は、現金での支払いとなります。

支払期限は8月26日(金)です。支払予定日時を以下の担当係へメール連絡したうえで、お釣りのないよう以下に以下の担当係まで学生証とともに持参してください。窓口へは出来る限り 10:00-12:00、13:00-16:00 にお越しください。

預金口座が未登録である等、授業料の納入についてのお問い合わせは、本紙末尾の担当係にご連絡ください。

納入がない場合は、名古屋大学通則または名古屋大学大学院通則により教授会等の審議を経て、除籍となる恐れがあります。

Those who get the result of "Approved (Two-Thirds Exemption)", "Approved (Half Exemption)", "Approved (One-Third Exemption)", "Approved (One-Quarter Exemption)", "Approved (Partial Exemption)", "Not Approved" should pay your tuition fee.

The tuition fee amount will be debited directly from your bank account on August 26, 2024. Please make sure you have the following amount in your account by the day before.

Students approved for One-Quarter Exemption	Amount of payment: ¥200,900
Students approved for Partial Exemption	Amount of payment: ¥207,900
Students not approved for exemption	Amount of payment: ¥267,900

If you have recently arrived in Japan and do not have a bank account, you will be required to pay in cash.

Please email the accounting section in charge below with the payment date and time. Please have the exact amount of payment ready.

Please bring your student ID card and cash to the accounting section in charge below by August 26th.

Please come to the counter between 10:00-12:00 and 13:00-16:00 as much as possible.

If you have not registered bank account yet and have questions about tuition fees, please contact the accounting section in charge below.

If you do not pay the tuition fee, according to the rules of Nagoya University or the rules of Nagoya University Graduate School, the student will be unregistered from the school after being deliberated at the faculty meeting.
